



\*\* NOTICE: Production lead time required for this project is 2 weeks. Please submit graphic files by 14 days prior to ship date. Graphic proof approvals are due 10 days prior to ship date. All changes made after this date are subject to additional design time and 50% rush charges. Estimate is valid for 30 days.

#### **Payment Terms:**

Payment is due 100% at signing. A one- and one-half percent (1.5%) monthly service charge will be assessed against late payments. If the balance due is not received within 60 days from date of final invoice, Client authorizes Meeting Shield's Manufacturing Partner to charge the credit card listed at the end of this agreement. Grant of copyright is conditioned upon receipt of final payment, and upon Client's compliance with the terms of this agreement.

### **Damage/Loss:**

Client agrees that Meeting Shields, LLC, shall be compensated for all lost or damaged rental equipment at 3.5 times the rental cost. Charges are to be applied to final invoice or are to be invoiced supplementally if final invoice has been submitted for payment.

## **Cancellation/Postponement:**

It is the intent of all parties that this agreement is binding and noncancellable, however, in the event of cancellation/postponement, Meeting Shields, LLC will be compensated for services and/or products performed through the date of cancellation.
